6TH MARCH 2024 - 950 CATTLE YARDED

With this fortnights sale we had another outstanding yarding with a good run of yearling and prime cattle. With the dryer weather around we found buyers being more picky this week with yearling and feeders leading to firm to cheaper trends for the second types. Prime steers were firm to 3c/kg dearer with the top pen making 323.2c/kg. We had another great run of cows this fortnight with the leads of the cows making up to 248.2c/kg being 8c/kg dearer on last fortnights sale. There was strong competition on all heavy stock with the best heavy bull making 258c/kg.






